PROCUREMENT OF FURNITURE FOR NRHM

It is requested that quotation indicating the rate for different items be furnished to enable this Directorate to place the orders for supply from time to time

Terms & conditions

It may be noted that quotations with different specifications shall not be considered. Rates shall be quoted for each brand of items separately in the table indicated above Annexure-I. Rates should not be more than MRP.

- The supplier selected shall have the responsibility to supply above mentioned items as per supply order of Mission Directorate, National Rural Health Mission, Orissa.
- The suppliers shall also ensure that the quality and quantity has to be as per the supply order and approved rate.
- The firm should have PAN/TIN holder & with authorization letter from Godrej furniture.
- The firm should have up-to-date VAT clearance certificate (Valid up to 31st March 2011)
- The supply of items shall be made immediately (within 10 day) after placing the supply order in the Office of the Mission Directorate, National Rural Health Mission (Annex building of SIHFW), Nayapally, Unit –8, Bhubaneswar, Orissa and supplier shall submit the bill for payment at the approved rate in respect to the quantity of items supplied. The delay in supply will impose penalty @ 0.5% per week (Max. to 10 % of the bill amount.
- Only those firms/ Agencies should participate in the tender who are willing to supply all the items. Firms/Agencies who don't quote the rates for all items are liable to be rejected.
- The quotation may be furnished in the sealed covered by 7th September 2010 (1.00 PM) and dropped in the tender box kept in the reception (Tel No.0674-2392480/88)
- The quotation shall be opened 7th September 2010 at 4.00 P.M. in the conference hall of Mission Directorate, NRHM in the presence of tenders or their authorized representative who may wish to be present.
- For any dispute, decision of Mission Director shall be final.
- The Mission Director, National Rural Health Mission, Orissa reserves its right to accept or reject any or all quotations or any part thereof without any liability to communicate any reason.
- Rates shall be quoted for each item as per specification mentioned in annexure-I

- Rate should not be more than MRP.
